SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Detection Reagent: 10 mL Liquid

Contains 0.1-2% o-phthalaldehyde (CAS #: 643-79-8), 0.1-1% β-Mercaptoethanol (CAS#: 60-24-2), and 1-10% dimethyl sulfoxide (CAS#: 67-68-5)

Standard: 120 µL Liquid

SECTION 4. FIRST AID MEASURES
