

SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Nonhazardous. Diaphorase: 120 µL Liquid Nonhazardous. NAD Solution: 1 mL Liquid Nonhazardous.

MTT Reagent: 1.5 mL Liquid

Contains 0.1-2% thiazolyl blue tetrazolium bromide (298-93-1) Calibrator: 1.5 mL liquid Contains 10-50% Isopropanol (CAS #: 67-63-0)

SECTION 4. FIRST AID MEASURES

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.
