SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

Contains 0.1-5% Triton X-100 (CAS #: 9002-93-1) and 3% hydrazine (CAS #: 302-01-2)

SECTION 4. FIRST AID MEASURES

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Evelids should be held away from the eveball to ensure thorough rinsing. Get immediate medical attention.
