#### SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Assay Buffer: 25 mL Liquid Non-hazardous. Reagent A: 10 mL Liquid Non-hazardous. Reagent B: 10 mL Liquid Contains 1-20% glycerol (CAS #: 56-81-5) Standard: 100 μL Liquid Contains 0.1-5% hydrogen peroxide (CAS#: 7722-84-1).

# **SECTION 4. FIRST AID MEASURES**
